Clerk to write to WBC opposing this application on the grounds that the proposal is outside the settlement boundary. The area has become derelict over the years but this should not be a reason to allow development. On examining the plans (document MLP/01) the area is designated in red at the front and blue at the back, BPC wish to know the status of the area edged in blue at the rear. The concern is that a precedent will be set to develop the whole area of land between Coombes Lane and Hayes Lane and then this Area of Special Landscape Importance will be lost. The Village Design Statement should be consulted for all new applications.

Mr Steepe the Enforcement Officer at WBC has now reported from the site meeting which took place on 9th July with the owner, Ms Jackson and Mr Howard (Planning Officers from WBC). With regard to the stables Mr Flaherty is considering re submitting an application for the stables on a reduced scheme which will regularise the hard standing issue. In respect of the African Hut Mr Flaherty is considering making an application to re site this hut. Mr Flaherty was informed that any application should be submitted within 28 days of the meeting and if not forthcoming the Council will expect compliance and will consider taking the appropriate action to remedy failure to comply with the Enforcement Notice.
